

WEATHER SUMMARY:

We are entering a warming trend. Today's temperatures should be 83-85 degrees with relative humidity near 22-25. Eye level winds should be light and variable in the morning increasing to 3-6 mph from the west to northwest in the afternoon. Extended outlook is for hot and dry weather without any precipitation predicted for the next ten days.

FIRE BEHAVIOR

GENERAL:

The fire should remain fairly inactive until the afternoon. In the timber, expect forward rates of spread of 6-14 chains/hour with flame lengths of 4 feet. Expect some torching and possible crowning in runs up the steeper slopes. Backing fires should have flame lengths of 1-2 feet with a ROS of less than 2 chains/hour.

In the more open, grassy areas expect uphill runs with flame lengths of 3-4 feet and ROS over 50 chains/hour. The fires will back down the hill at 5-7 chains per hour with flame lengths of 1-2 feet.

SPECIFIC:

DIVISION A, B, C, D & F - This portion of the fire is lined. There has not been much fire activity the last two days. I do not expect any significant fire activity in these divisions.

DIVISION E - The fire in this division has been lined. However, there were some fires that spotted across the line yesterday. Expect some activity in these divisions from unburned pockets adjacent to the fire line.

There may be some torching of individual and groups of trees. Watch out for spot fires that were not detected yesterday.

DIVISION G, H, I & J - In the timber, expect the fire to be relatively inactive in the morning with activity picking up in the afternoon. Expect some uphill runs with flames lengths of 4+ feet and ROS of 10 feet/minute. If this occurs expect some torching will occur with short range spotting of less than 1/4 of a mile. The fuels in these divisions become more sparse on the ridgetops and as you near the Boise River. The fire will not burn as intensely in these areas but with significantly higher ROS. These fuels will not sustain a fire and will usually go out in the evening, especially near the valleys where the maximum relative humidity is usually over 50%. Retardant is usually effective in controlling fire spread in this type of fuel.

AIR OPERATIONS:

Smoke may limit air operations in the morning. Skies should clear in the PM.

SAFETY:

There is a possibility that a subsidence inversion set up over the area last night. If these occurred RH's will remain high until the afternoon and then plummet to 15%. If this is the case, a plume dominated fires with long range spotting is possible.



FIRE BEHAVIOR ANALYST

WEATHER SUMMARY:

Expect an inversion in the AM. Skies should be mostly sunny in the afternoon with variable mid and high clouds. Temperatures should be slightly cooler in the low to mid 70's with relative humidity between 15-25%. The eye level winds should be light and variable in the morning increasing 2-5 MPH in the afternoon. Winds on the ridges should be out of the southwest at 6-8 MPH. Haines index is expected to be 5, moderate.

FIRE BEHAVIOR

GENERAL:

Clouds and higher humidity should help moderate fire behavior. Skies should remain fairly inactive until the morning inversion lifts. In the timber, expect forward rates of spread of 6 chains/hour with flame lengths of 2-3 feet. Expect some torching in fires that run up the steeper slopes. Backing fires should have flame lengths of 1-2 feet with a ROS of less than 2 chains/hour. Here the fires will back down the hill with flame lengths of 1 foot. The aspen and ceanothus will act as a natural fire break.

SPECIFIC:

DIVISION A, B, C, D & F - I do not expect any significant fire activity in these divisions. There are still some unburned patches of fuel in E from the burnout. These areas should continue to burn but should not give us any problems.

DIVISION H & J - In the timber, expect the fire to be relatively inactive in the morning with activity picking up in the afternoon. Expect some uphill runs with a spotting distance of .5 miles. Winds will be squirrely in those canyons. The fuels in these divisions become more sparse on the ridgetops. The fire will not burn as intensely in these areas.

DIVISION G & I - Fire will continue to back towards the river. There are some unburned patches of fuel in these areas. There will be some torching but should not threaten control lines.

AIR OPERATIONS:

Smoke may limit air operations in the AM. The inversion should lift in the early PM and skies should remain clear.

SAFETY:

There is a possibility that a subsidence inversion set up over the area last night. If this occurred RH's will remain high until the afternoon and then plummet to 15%. If this is the case, a plume dominated fire with long range spotting is possible.



WEATHER SUMMARY:

Expect an inversion in the AM. Skies should be mostly sunny in the afternoon with variable mid and high clouds. Temperatures should be slightly cooler in the low to mid 70's with relative humidity between 15-25%. The eye level winds should be light and variable in the morning increasing 2-5 MPH in the afternoon. Winds on the ridges should be out of the southwest at 6-8 MPH. Haines index is expected to be 5, moderate.

FIRE BEHAVIOR

GENERAL:

Clouds and higher humidity should help moderate fire behavior. Skies should remain fairly inactive until the morning inversion lifts. In the timber, expect forward rates of spread of 6 chains/hour with flame lengths of 2-3 feet. Expect some torching in fires that run up the steeper slopes. Backing fires should have flame lengths of 1-2 feet with a ROS of less than 2 chains/hour. Here the fires will back down the hill with flame lengths of 1 foot. The aspen and ceanothus will act as a natural fire break.

SPECIFIC:

DIVISION A, B, C, D & F - I do not expect any significant fire activity in these divisions. There are still some unburned patches of fuel in E from the burnout. These areas should continue to burn but should not give us any problems.

DIVISION H & J - In the timber, expect the fire to be relatively inactive in the morning with activity picking up in the afternoon. Expect some uphill runs with a spotting distance of .5 miles. Winds will be squirrely in those canyons. The fuels in these divisions become more sparse on the ridgetops. The fire will not burn as intensely in these areas.

DIVISION G & I - Fire will continue to back towards the river. There are some unburned patches of fuel in these areas. There will be some torching but it should not threaten control lines.

AIR OPERATIONS:

Smoke may limit air operations in the AM. The inversion should lift in the early PM and skies should remain clear.

SAFETY:

There is a possibility that a subsidence inversion set up over the area last night. If this occurred RH's will remain high until the afternoon and then plummet to 15%. If this is the case, a plume dominated fire with long range spotting is possible.

2. Know what your fire is doing at all times
3. Base all actions on current and expected behavior of the fire.
4. Identify escape routes and safety zones, and make them known.
5. Post lookouts when there is possible danger.
6. Be alert. Keep calm. Think clearly. Act decisively.
7. Maintain prompt communications with your forces, your supervisor and adjoining forces.
8. Give clear instructions and insure they are understood.
9. Maintain control of your forces at all times.
10. Fight fire aggressively, having provided for safety first.



WEATHER SUMMARY:

Expect an inversion in the AM. Skies should be mostly sunny in the afternoon with variable mid and high clouds. Temperatures should be slightly cooler in the low to mid 70's with relative humidity between 15-25%. The eye level winds should be light and variable in the morning increasing 2-5 MPH in the afternoon. Winds on the ridges should be out of the southwest at 6-8 MPH. Haines index is expected to be 5, moderate.

FIRE BEHAVIOR

GENERAL:

Clouds and higher humidity should help moderate fire behavior. Skies should remain fairly inactive until the morning inversion lifts. In the timber, expect forward rates of spread of 6 chains/hour with flame lengths of 2-3 feet. Expect some torching in fires that run up the steeper slopes. Backing fires should have flame lengths of 1-2 feet with a ROS of less than 2 chains/hour. Here the fires will back down the hill with flame lengths of 1 foot. The aspen and ceanothus will act as a natural fire break.

SPECIFIC:

DIVISION A, B, C, D & F - I do not expect any significant fire activity in these divisions. There are still some unburned patches of fuel in E from the burnout. These areas should continue to burn but should not give us any problems.

DIVISION H & J - In the timber, expect the fire to be relatively inactive in the morning with activity picking up in the afternoon. Expect some uphill runs with a spotting distance of .5 miles. Winds will be squirrely in those canyons. The fuels in these divisions become more sparse on the ridgetops. The fire will not burn as intensely in these areas.

DIVISION G & I - Fire will continue to back towards the river. There are some unburned patches of fuel in these areas. There will be some torching but it should not threaten control lines.

AIR OPERATIONS:

Smoke may limit air operations in the AM. The inversion should lift in the early PM and skies should remain clear.

SAFETY:

There is a possibility that a subsidence inversion set up over the area last night. If this occurred RH's will remain high until the afternoon and then plummet to 15%. If this is the case, a plume dominated fire with long range spotting is possible.

7. Maintain prompt communications with your forces, your supervisor and adjoining forces.
8. Give clear instructions and insure they are understood.
9. Maintain control of your forces at all times.
10. Fight fire aggressively, having provided for safety first.
